## Calculation and Payment of Business Incentive Grant

Business Grant Incentives will be calculated based on the incremental assessed value of the building improvements, new construction or building expansion as provided by the local Manitoba Assessment Branch, times the general municipal mill rate in effect during the year it is calculated.

Grants will be awarded for up to five years, starting the year after completion of construction or occupancy. The term of the grant will be determined based on the incremental value of assessment, per the following table:

<b>Full Assessment Increase</b>	<b>Term of Grant</b>
\$10,000 - \$250,000	One Year
\$250,001 - \$400,000	Two Years
\$400,001 - \$600,000	Three Years
\$600,001 - \$750,000	Four Years
More than \$750,001	Five Years

Grants will be paid at the end of the calendar year on a declining scale based on the amount of the grant in Year One. The scale of grant payments is as follows:

Year 1	100%
Year 2	75%
Year 3	50%
Year 4	25%
Year 5	10%

### Example

#### **New Building Constructed for a New Business**

**Full Assessed value of new building: \$800,000**

**Term of Grant (more than \$750,001): 5 Years**

#### **Calculation of Grant:**

Portioned assessment of new building:  $\$800,000 \times 65\% = \$520,000$

General Municipal Mill rate for year assessed = 7.45

**Full Amount of grant used for annual calculations:  $520,000/1,000 \times 7.45 = \$3,874.00$**

Year 1:  $\$3,874.00 \times 100\% = \$3,874.00$

Year 2:  $\$3,874.00 \times 75\% = \$2,905.50$

Year 3:  $\$3,874.00 \times 50\% = \$1,937.00$

Year 4:  $\$3,874.00 \times 25\% = \$968.50$

Year 5:  $\$3,874.00 \times 10\% = \$387.40$

**Total grant received over 5 years: \$10,072.40**
